- If HMRC select you for enquiry they will potentially look at all your books and records and/or ask for more detail on specific transactions and may then raise an assessment for additional tax due.

When HMRC comes knocking...

Case of mistaken identity, a husband & wife partnership selling and installing double glazing was investigated by HMRC. At a meeting, HMRC alleged the husband had been dishonest. By the end of a long and detailed enquiry, HMRC repaid $\mathfrak{L}129$ of tax to the partnership and apologised, confirming that the allegation of dishonesty was a case of mistaken identity. Accountancy fees were approximately $\mathfrak{L}5,000$ and were protected in full by the Tax Fee Protection.
