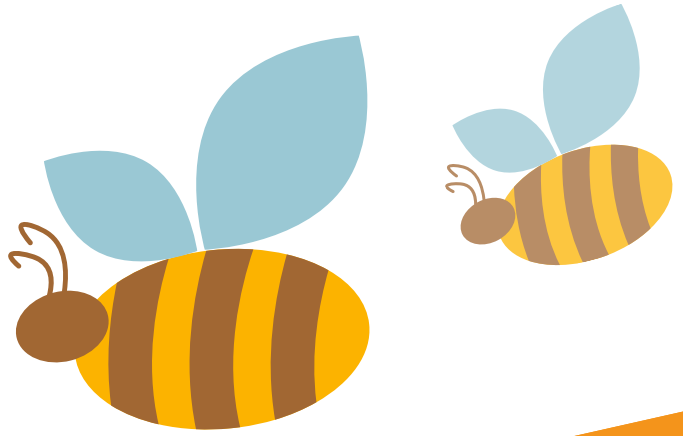

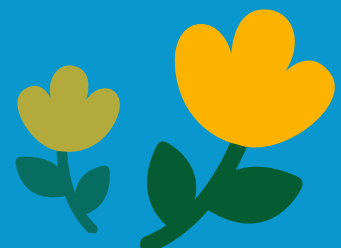
What could an enquiry involve?
